

# TRAVEL IN NEW CALEDONIA

COVID-19 ENTRY REQUIREMENTS ON 18/03/2022



## VACCINATED TRAVELLERS

12 YEARS AND OLDER WITH 2 DOSES (+ 1 BOOSTER DOSE OF MRNA VACCINE 9 MONTHS LATER)<sup>1</sup>

CHILDREN stay with their parents but are exempt from vaccination and testing.



## NON-VACCINATED TRAVELLERS

12 YEARS AND OLDER WITH OR WITHOUT MEDICAL CONTRAINDICATION

According to Australian standards, you need to apply for a travel exemption to leave Australia.

### UPON BOARDING

- Present proof of **complete vaccination scheme**<sup>1</sup>.
- Present a **negative test** (RAT or RT-PCR less than 24h).
- Complete and sign an **attestation on honor**<sup>2</sup>.



- Provide evidence of a **compelling reason**<sup>3</sup> to travel (personal, professional or health) that cannot be deferred.
- Present a **negative test** (RAT or RT-PCR less than 24h).
- Complete and sign an **attestation on honor**<sup>2</sup>.

### DURING THE FLIGHT

- Over 6 years old, it is mandatory to **wear a surgical mask** at check-in, during the entire flight and until arrival.

### ON ARRIVAL

- Take a **RAT or RT-PCR test 48h after their arrival** and keep the proof of the negative test result (available free of charge in pharmacies or screening centres upon presentation of the passport).



- Do a **7-day quarantine** in his accommodation in New Caledonia.
- Do **2 tests** (RAT or RT-PCR) on day 2 and then on day 7 of self-isolation.

### DURING YOUR STAY

- In case of **COVID-19 contamination**, isolate yourself for 5 days in your accommodation and perform another RAT test after 5 days. If your test is negative and you have no symptoms, you can leave isolation.
- For non-European Union citizens, **travel insurance is mandatory** to cover the cost of care on site.

### BACK TO AUSTRALIA

- Submit the **Digital Passenger Declaration**<sup>4</sup> minimum 72 h before your departure to Australia.
- Present proof of **complete vaccination scheme**<sup>4</sup>.
- Present a **negative test** (RT-PCR less than 96h or RAT less than 24h).
- You should do a RAT test at home within 24h of arrival.



- Submit the **Digital Passenger Declaration**<sup>4</sup> minimum 72 h before your departure to Australia.
- Provide evidence of an **exemption of travel** or a **medical certificate of vaccination contraindication**<sup>4</sup>.
- Present a **negative test** (RT-PCR less than 96h or RAT less than 24h).
- Respect a **mandatory hotel quarantine** (duration varies by state).
